From Hartsfield International Airport via MARTA

1. Take the Northbound Line (Doraville or Dunwoody) MARTA train to the Five Point Station
2. Exit the Five Points Station to Forsyth Street, turn left onto Forsyth
3. Atlanta Federal Center Tower entrance is in the Plaza behind the McDonald's

From Interstate 75/85 Northbound (Airport Area)

1. Take Interstate 85 north (will merge with Interstate 75 north) to downtown.
2. Exit # 91 (Fulton Street/Central Avenue)
3. From Central Avenue turn left on Martin Luther King Drive
4. Atlanta Federal Center will be on your right at the corner of Martin Luther King Jr., Drive and Forsyth Street (Atlanta Federal Center tower is on the left)

From Interstate 75/85 Southbound

1. Take Interstate 75 or 85 south (will merge just before downtown Atlanta)
2. Exit # 93 (Martin Luther King, Jr. Drive/State Capital)
3. Atlanta Federal Center will be on your right at the corner of Martin Luther King Jr., Drive and Forsyth Street (Atlanta Federal Center tower is on the left)

From Interstate 20 Westbound

1. Exit #22 (Windsor Street/Spring Street); Turn right
2. Turn right on Mitchell Street
3. Turn left on Forsyth Street
4. Atlanta Federal Center Tower will be on your left

From Interstate 20 Eastbound

1. Exit #22 (Windsor Street/Spring Street); Turn left
2. Turn right on Mitchell Street
3. Turn left on Forsyth Street
4. Atlanta Federal Center Tower will be on your left
