SUMMARY OF FINDINGS

IR 50-298/01-301; on March 30, 2001; Nebraska Public Power District; Cooper Nuclear Station; retake examination.

NRC examiner evaluated the competency of one applicant for a reactor operator license at the Cooper Nuclear Station facility. The facility developed the written examination using NUREG-1021, "Operator Licensing Examination Standards for Power Reactors," Revision 8, Supplement 1. The written examination was administered to the applicant on the morning of March 29, 2001, by facility proctors in accordance with instructions provided by the chief examiner. The NRC chief examiner reviewed the grading of the examination on April 9, 2001.

4. OTHER ACTIVITIES (OA)

40A4 Retake License Examination

.1 Operator Knowledge and Performance

a. <u>Inspection Scope</u>

The licensee developed the written examination using facility training and operations staff on the security agreement to prepare and validate the examination. On March 29, 2001, the licensee proctored the administration of the written examination to the applicant. The licensee staff graded the written examination, analyzed the results, and presented their evaluation to the NRC on April 5, 2001. The categories of the operating test were waived on March 26, 2001.

b. Findings

The applicant passed the written examination. The reactor operator applicant scored 84 percent.

The licensee did not recommend any questions for modification during their postexamination review. The text of the examination questions may be accessed in the ADAMS system under Accession Nos. ML011280214 and ML011270228.

.2 Initial Licensing Examination Development

The facility training staff developed the written retake examination in accordance with NUREG-1021, Revision 8, Supplement 1.

.2.1 Examination Outline and Examination Package

a. Inspection Scope

The facility licensee submitted the written and operating examination outlines and the draft examinations on March 12, 2001. The chief examiner reviewed the submittal against the requirements of NUREG-1021, Revision 8, Supplement 1, and provided comments to the licensee on March 21, 2001. The licensee incorporated any substantive comments and prepared the examination for administering on March 29, 2001.

b. Findings

Region IV approved the retake examination outline and determined that the written examination initially submitted by the licensee was within the range of acceptability expected for a proposed examination.

Exit Meeting Summary

The examiner presented the examination results to Mr. Don Olesen during a telephone conference at the conclusion of the inspection on April 10, 2001. The licensee acknowledged the findings presented.

The licensee did not identify as proprietary any information or materials examined during the inspection.
