# Comments on NRC Draft Regulatory Guide DG-1087, "Evaluating the Habitability of a Nuclear Power Plant Control Room during a Postulated Hazardous Chemical Release"

## 1) Section 3.4 - Control Room Air Flow:

In the last sentence of this section, replace the word "particulate" with "toxic substance" since not all toxic chemicals are particulate.

2) Section 4.1 - Detection System:

For clarity, a statement should be added to state "Where no specific threat from toxic gas has been identified, no toxic gas detection systems are required."
