**Re: Freedom of Information Act Request**

Dear Ms. Reed:

Pursuant to the Freedom of Information Act (FOIA), 5 U.S.C. § 552, and 10 C.F.R. Part 9, Subpart A, I hereby request copies of any and all licenses, permits, records, correspondence, surveys, reports and documents related to environmental conditions at any facility located in Bayside, New York that was in operation at any point between 1945 and 1970 and was, at any point during that time, licensed to receive, distribute, process, handle, use, or store radioactive materials. In particular, the information should include **all documents, regardless of date**, related to these facilities, including: (1) copies of any and all Atomic Energy Commission ("AEC") licenses associated with the facility during that time period and related correspondence and documents; (2) inspection reports and annual reports of the site and related correspondence and documents; (3) closure, decommissioning, decontamination or similar reports or assessments and related correspondence, surveys and documents.

Please have the FOIA Coordinator assigned to this request contact me once he or she has identified the documents that fall within the scope of this request, so that we can discuss, prior to copying the materials, how to potentially narrow the scope of this request. I am, of course, willing to pay the reasonable costs associated with this request. I can be reached at (303) 454 2439.


