Reference 1 provided a series of requests for additional information on our WOG Generic Technical Report discussing reactor vessel underclad cracking. The WOG was requested to also provide a schedule for submittal of responses to these RAIs, consistent with the ongoing review of the FPL Turkey Point License Renewal Application.

Our planned schedule for completion of the responses to these RAIs is the end of May 2001. Prior to the formal transmittal of our responses, there may be some discussion between the Westinghouse technical author and the NRC cognizant reviewer to assure that the RAI responses provide adequate information.

Upon acceptance of the RAI responses by the NRC, a Final Safety Evaluation should be issued. The WOG will then follow the procedure in Reference 2 which was used in the issuance of Final Safety Evaluations for several of the WOG Aging Management Topical Reports:

The Westinghouse Owners Group will then issue approved versions of the reports (WCAP-xxxxs-A) containing:

- *The WCAP report, as reviewed by NRC*
- *The RAI response transmittal letter from WOG to NRC, as reviewed by NRC*
- *The FSE, as issued*

No editing of the original WCAP report or RAI responses will be performed for these approved documents.


