SUBMITTAL OF DOCUMENTARY EVIDENCE OF INSURANCE
NUCLEAR MANAGEMENT COMPANY, LLC

By letter dated April 19, 2001, the Nuclear Regulatory Commission issued an Order to Consumers Energy Company approving the transfer of operating authority under Facility Operating License No. DPR-20, held by Consumers Energy Company for the Palisades Plant, to Nuclear Management Company, LLC (NMC). The Order also approved a conforming license amendment, which will be issued and made effective at the time the transfer is completed.

The Order approved the proposed transfer subject to two conditions. Condition (2) in the Order requires:

NMC shall, prior to completion of the transfer of operating authority for Palisades, provide the Director of the Office of Nuclear Reaction Regulation satisfactory documentary evidence that NMC has obtained the appropriate amount of insurance required of licensees under 10 CFR Part 140 of the Commission's regulations.

Attached are Certificates of Insurance which provide documentary evidence that NMC has obtained the appropriate amount of insurance as required of licensees under 10 CFR Part 140. The attachments include nuclear liability Certificates of Insurance for Policies NF-179, N-17 and NW-566. Also attached are property Certificates of Insurance for Policies P00-017 and X00-012.
