The purpose of this modification is to incorporate the enclosed change to the statement of work, increase the ceiling amount of the task order, and to extend the expiration date of the period of performance from April 27, 2001, to June 30, 2001.

The ceiling of the task order is increased by \$18,935, from \$170,536, to \$189,471. The amount of \$170,626 represents reimbursable costs, the amount of \$5,369 represents the cost of facilities capital, and the sum of \$13,476 represents the fixed fee.

## Modification No. 5 to Task Order 8 Under NRC-02-98-002

Modify Section 6, sub-task G as follows:

"The contractor shall make a presentation of the findings from this task order at the NMS/NRC Annual workshop to be held on June 13 or 14 in Denver, Colorado".

Modify Section 7, Meetings and Travel, as follows:

"NRC also anticipates one trip to Denver, Colorado in June (2 people, 3 days) for the purpose of presenting the findings of this task order and participating in the NMS/NRC Uranium Recovery Workshop. No other travel is anticipated".
