<u>Response To Regulatory Issue Summary 2001-08</u> <u>Docket Nos. 50-255, 50-263, 50-266, 50-282, 50-301, 50-305, 50-306, and 50-331</u> <u>Nuclear Management Company, LLC</u>

The Nuclear Regulatory Commission, in Regulatory Issue Summary 2001-08 dated April 2, 2001, requested licensees to voluntarily provide a numerical estimate of the number of licensing actions projected for submittal during Fiscal Years (FY) 2001 and 2002. In addition, a brief summary of those actions likely to require complex reviews was requested. The following represents the number of licensing actions expected to be submitted for the remainder of FY 2001 (ending September 30, 2001) and for FY 2002.
