The purpose of this modification is to extend the contract expiration date by three months to December 31, 2001 at no change to the contract estimated cost or fixed fee. Accordingly, the contract is modified as follows:

1. The contract expiration date is hereby by changed to December 31, 2001 at no change to the contract estimated cost for fixed fee. in consideration for this extension, the contractor shall provide two development assessments in letter report format by December 31, 2001. The development assessments shall be(1) an assessment of subcooled void model installed into TRAC-M and(2) an assessment on the mechanistic separator model in TRAC-M. These assessments are hereby added as deliverable line items in Section F.7 of the contract.

2. As a result of the above, Section F.6 of the contract is hereby replaced by the following F.6 $\,$

F.6 DURATION OF CONTRACT

The contract shall commence on September 23, 2001 and will expire on December 31, 2001.

3. All other terms and conditions will remain unchanged.
