


The purpose of this Modification No. 3 is to incorporate the Contractor's (Advanced Technologies and Laboratories International, Inc.) Indirect Rates for Calendar Year 2000. Therefore, Section G.4 2052.216-71 INDIRECT COST RATES, paragraph (a), is revised to read as follows:

"(a) Pending the establishment of final indirect rates which must be negotiated based on audit of actual costs, the contractor shall be reimbursed for allowable indirect costs as follows:
