AFFIDAVIT OF BARRY R. LETTS IN SUPPORT OF THE NRC STAFF'S MOTION TO HOLD PROCEEDING IN ABEYANCE

- I, Barry R. Letts, first being duly sworn, depose and state:
- 1. I am the Region 1 Field Office Director, Office of Investigations, U.S. Nuclear Regulatory Commission. The Office of Investigations (OI), pursuant to 10 C.F.R. 1.36, carries out investigations of alleged wrongdoing by licensees, applicants and vendors, or their contractors. One of OI's responsibilities is to investigate alleged violations of NRC rules and regulations and to determine whether such alleged violations merit referral to the United States Department of Justice (DOJ) for criminal consideration pursuant to a Memorandum of Understanding, 53 Fed. Reg. 50317 (December 14, 1988).
- 2. The purpose of this affidavit is to inform the Atomic Safety and Licensing Board presiding over the above-captioned NRC proceeding that OI is conducting an ongoing investigation of an allegation concerning Northeast Nuclear Energy Company's conduct relating to the reporting of missing fuel pins at the Millstone Unit 1 spent fuel pool.
- 3. The Atomic Safety and Licensing Board adjudicatory proceeding and the OI investigation presently ongoing appear to involve, in part, the same factual allegations. Furthermore, I believe that some persons employed by the NRC and/or the licensee necessarily may be involved in both the adjudicatory proceeding and OI's ongoing investigation. On the basis

of my initial review of this matter, I believe that continuing the NRC adjudicatory proceeding at this time could interfere with or jeopardize the integrity of Ol's ongoing investigation.

- 4. Due to the scope of the ongoing investigation, I estimate that the OI investigation and the decision whether to refer the matter to the Department of Justice for criminal consideration will be completed by late summer, subject to the possibility that there may be investigative delays that are not anticipated at this time.
- 5. The matters stated above are true and correct to the best of my knowledge, information and belief.
