For the Passive Utility Requirements. Document:

The URD is complete. We didn't asked for NRC review past rev 4 [leading to NRC-initiated changes through rev 6], and we have no current plans for changes beyond those processed through '98.

For the Qualification Program for Progamable Logic Controllers The reviews for the PLC work are still open.

- 1. For Westinghouse (ABB/CE) Common Q, additional qualification work is being done and will be submitted to NRC. The SER on the first submittal was received last year.
- 2. For Framatome (Siemens) Teleperm XS, some additional qualification work is being done and probably will be submitted to NRC. The SER on the first submittal was received last year.
- 3. For Triconex Tricon, NRC is in the process of reviewing the topical.
- 4. Two other companies have contacted EPRI about possibly working with us to develop a submittal on their products. We do not know at this time if this will happen or not.
