SUBJECT: MAIN STACK AND VENT STACK RADIATION MONITOR TECHNICAL SPECIFICATIONS, PEACH BOTTOM ATOMIC POWER STATION, UNIT NOS. 2 AND 3 (TAC NOS. M90947 AND M90948)

Dear Mr. Hunger:

The Commission has issued the enclosed Amendments Nos. 204 and 207 to Facility Operating License Nos. DPR-44 and DPR-56 for the Peach Bottom Atomic Power Station, Unit Nos. 2 and 3. These amendments consist of changes to the Technical Specifications (TS) in response to your application dated November 17, 1994 as supplemented by letter dated March 30, 1995.

These amendments change equipment designations, instrument range descriptions, instrument setpoints and surveillance requirements in the Peach Bottom TS to reflect planned modifications to the main stack and vent stack radiation monitoring systems.

You are requested to inform the staff when you have implemented the provisions of these amendments. The requirement affects nine or fewer respondents and, therefore, is not subject to the Office of Management and Budget review under P.L. 96-511.

A copy of the Safety Evaluation is also enclosed. Notice of Issuance will be included in the Commission's Bi-Weekly Federal Register Notice.
