## A. QUALITY SYSTEMS

The Manager, Quality Systems, is responsible for:

- Management of Quality Systems activities associated with the Nuclear Operations Division. Tasks included within these activities are:
  - a. Providing the VPNO with assurance of compliance to regulatory codes and standards, through audits, surveillance, assessments and/or reviews
  - Identification of any quality problems to appropriate NOD management
  - c. Selected Health Physics oversight requirements such as:
    - 1) Inputting information to the SCE&G ALARA Program
    - Developing the necessary oversight of procedures to monitor the performance and scope of activities of Health Physics
    - 3) Developing, recommending, implementing and overseeing programs with regard to radiological affairs
    - 4) Providing Health Physics support and recommendations to plant design and operational activities through technical reviews
  - d. Implementation of the QC inspection and Inservice Inspection programs.
  - e. Administering the Station Nonconformance Program
  - f. Administering the Condition Evaluation Report Program
- 2. Management of the Independent Safety Engineering Group (ISEG).

Providing independent review of plant activities to verify compliance to the operating license. These activities may include evaluation of plant operating characteristics, NRC issues, industry advisories, or others.
