AMENDMENT TO CONSTRUCTION PERMIT


Construction Permit No. CPPR-106
Amendment No. 1

Pursuant to a Decision by the Atomic Safety and Licensing Appeal Board dated March 19, 1975, the Nuclear Regulatory Commission has issued Amendment No. 1 to Construction Permit No. CPPR-106 by revising paragraph 3.E(8) in its entirety to read as follows:

"The applicant will take those measures necessary to assure the availability of compensating water storage capacity at the earliest practicable time if such is permitted by the Delaware River Basin Commission pursuant to DRBC Docket No. D-69-210CP. A schedule identifying significant milestone dates to achieve this objective, assuming Tocks Island project is not available, shall be developed in coordination with the Delaware River Basin Commission and submitted to the Division of Reactor Licensing within six months after the issuance of a construction permit for the station."

This Amendment is effective as of its issuance date.



Pursuant to a Decision by the Atomic Safety and Licensing Appeal Board dated March 19, 1975, the Nuclear Regulatory Commission has issued Amendment No. 1 to Construction Permit No. CPPR-107 by revising paragraph 3.E(8) in its entirety to read as follows:

"The applicant will take those measures necessary to assure the availability of compensating water storage capacity at the earliest practicable time if such is permitted by the Delaware River Basin Commission pursuant to DRBC Docket No. D-69-210CP. NOTICE OF ISSUANCE OF AMENDMENTS TO CONSTRUCTION

PERMITS AND NOTICE OF AVAILABILITY OF ATOMIC SAFETY

AND LICENSING APPEAL BOARD DECISION

Notice is hereby given that pursuant to a Decision issued by the Atomic Safety and Licensing Appeal Board on March 19, 1975, the Nuclear Regulatory Commission has issued Amendment No. 1 to Construction Permit No. CPPR 106 and Amendment No. 1 to Construction Permit No. CPPR 107 issued to the Philadelphia Electric Company for construction of the Limerick Generating Station, Units 1 and 2, located in Montgomery County, Pennsylvania. The Decision amends the construction permits by modifying one of the conditions for protection of the environment. Any decisions or actions taken by the Atomic Safety and Licensing Appeal Board in connection with this Decision may be reviewed by the Commission.

A copy of the Decision dated March 19, 1975, Amendment No. 1 to Construction Permit No. CPPR-106, Amendment No. 1 to Construction Permit CPPR-107, and the Nuclear Regulatory Commission's Final Environmental Statement are available for public inspection at the Commission's Public Document Room, 1717 H Street, N.W., Washington, D. C., and in the Pottstown Public Library, 500 High Street, Pottstown, Pennsylvania 19464.

The above noted documents are also available at the Office of Radiological Health, Department of Environmental Resources, Harrisburg, Pennsylvania 17105.

The Nuclear Regulatory Commission has found that the provisions of these amendments comply with the requirements of the Atomic Energy Act of 1954, as amended, and the Commission's regulations published in 10 CFR Chapter 1 and has concluded that the issuance of these amendments will not be inimical to the common defense and security or to the health and safety of the public.

The record developed in the public hearing in the above captioned matter modified in certain respects the contents of the Final Environmental Statement relating to the construction of the Limerick Generating Station, Units 1 and 2, prepared by the Nuclear Regulatory Commission. Pursuant to the provisions of Section 51.52(b)(3) of 10 CFR Part 51, the Final Environmental Statement is deemed modified to the extent that the conditions relating to environmental matters contained in the Decision are different from those contained in the Final Environmental Statement issued February 1974. As required by Section 51.52(b)(3) of 10 CFR Part 51, a copy of the Decision which modified the Final Environmental Statement has been transmitted to the Council on Environmental Quality and distributed to the Environmental Protection Agency and other interested agencies and persons in accordance with Section 51.26(c) of 10 CFR Part 51.

Single copies of the Decision, Amendment No. 1 to Construction Permit No. CPPR-106, Amendment No. 1 to Construction Permit No. CPPR-107, and the Final Environmental Statement may be obtained upon request addressed to the U. S. Nuclear Regulatory Commission, Washington, D. C. 20555, Attention: Director, Division of Reactor Licensing.
