AMENDMENT TO FACILITY OPERATING LICENSE

Amendment No. 154
License No. DPR-43

1. The U.S. Nuclear Regulatory Commission (the Commission) has found that:
 - A. The application for amendment by Nuclear Management Company, LLC (the licensee) dated April 6, 2001, complies with the standards and requirements of the Atomic Energy Act of 1954, as amended (the Act), and the Commission's rules and regulations set forth in 10 CFR Chapter I;
 - B. The facility will operate in conformity with the application, the provisions of the Act, and the rules and regulations of the Commission;
 - C. There is reasonable assurance (i) that the activities authorized by this amendment can be conducted without endangering the health and safety of the public, and (ii) that such activities will be conducted in compliance with the Commission's regulations;
 - D. The issuance of this amendment will not be inimical to the common defense and security or to the health and safety of the public; and
 - E. The issuance of this amendment is in accordance with 10 CFR Part 51 of the Commission's regulations and all applicable requirements have been satisfied.
2. Accordingly, the license is amended by changes to the Technical Specifications as indicated in the attachment to this license amendment, and paragraph 2.C.(2) of Facility Operating License No. DPR-43 is hereby amended to read as follows:

(2) Technical Specifications

The Technical Specifications contained in Appendix A, as revised through Amendment No. 154, are hereby incorporated in the license. The licensees shall operate the facility in accordance with the Technical Specifications.

3. This license amendment is effective as of the date of its issuance, and is to be implemented within 30 days of the date of issuance.

1.0 INTRODUCTION

By letter dated April 6, 2001, Nuclear Management Company, LLC (the licensee) submitted a proposed amendment to the Kewaunee Nuclear Power Plant (KNPP) Technical Specifications (TSs) to revise TS 6.2, "Organization," and TS 6.13, "High Radiation Area" to reflect the title change from Shift Supervisor to Shift Manager.

2.0 BACKGROUND

The regulation Title 10 of the Code of Federal Regulations (10 CFR) 50.36 states that Administrative Controls "are the provisions relating to organization and management, procedures, recordkeeping, review and audit, and reporting necessary to assure operation of the facility in a safe manner." The specific content of the administrative controls section of the TSs is, therefore, that information that the Nuclear Regulatory Commission (NRC) deems essential for the safe operation of the facility that is not already adequately covered by other regulations.

3.0 EVALUATION

The licensee proposes to change TS 6.2, "Organization," and TS 6.13, "High Radiation Area" to reflect the title change from Shift Supervisor to Shift Manager.

This change is administrative only and does not change the intent of the TSs or the responsibilities of the Shift Supervisor. This change simply clarifies that the Shift Supervisor is the Shift Manager, and is being made to make the KNPP TSs consistent with this title in KNPP's other policies and procedures.

This change to the TSs, which changes a title for consistency purposes is administrative and is therefore acceptable.

4.0 STATE CONSULTATION

In accordance with the Commission's regulations, the Wisconsin State official was notified of the proposed issuance of the amendment. The State official had no comments.

5.0 ENVIRONMENTAL CONSIDERATION

This amendment changes recordkeeping, reporting, or administrative procedures or requirements. Accordingly, the amendment meets the eligibility criteria for categorical exclusion set forth in 10 CFR 51.22(c)(10). Pursuant to 10 CFR 51.22(b) no environmental impact statement or environmental assessment need be prepared in connection with the issuance of the amendment.

6.0 CONCLUSION

The NRC staff has concluded, based on the considerations discussed above, that: (1) there is reasonable assurance that the health and safety of the public will not be endangered by operation in the proposed manner, (2) such activities will be conducted in compliance with the Commission's regulations, and (3) the issuance of this amendment will not be inimical to the common defense and security or to the health and safety of the public.
