Gentlemen:

Your letter dated September 25, 1973, proposed changes to the Technical Specifications of Facility License No. DPR-28 for the Vermont Yankee Nuclear Power Station that would reduce the maximum average planar heat generation rate for those fuel assemblies with deviant fuel enrichments to achieve conformance with the ECCS Interim Acceptance Criteria. The proposed change would provide an additional graph to Figure 3.5.1 of the Technical Specifications for the Vermont Yankee plant for those fuel assemblies containing deviant fuel enrichments.

We have reviewed your request and have determined that the proposed change does not present a significant hazards consideration and that there is reasonable assurance that the health and safety of the public will not be endangered by operation in the proposed manner.

Accordingly, pursuant to Section 50.59 of 10 CFR Part 50, the Technical Specifications appended to Facility License No. DPR-28 are hereby changed by adding the enclosed Figure 3.5.1A.

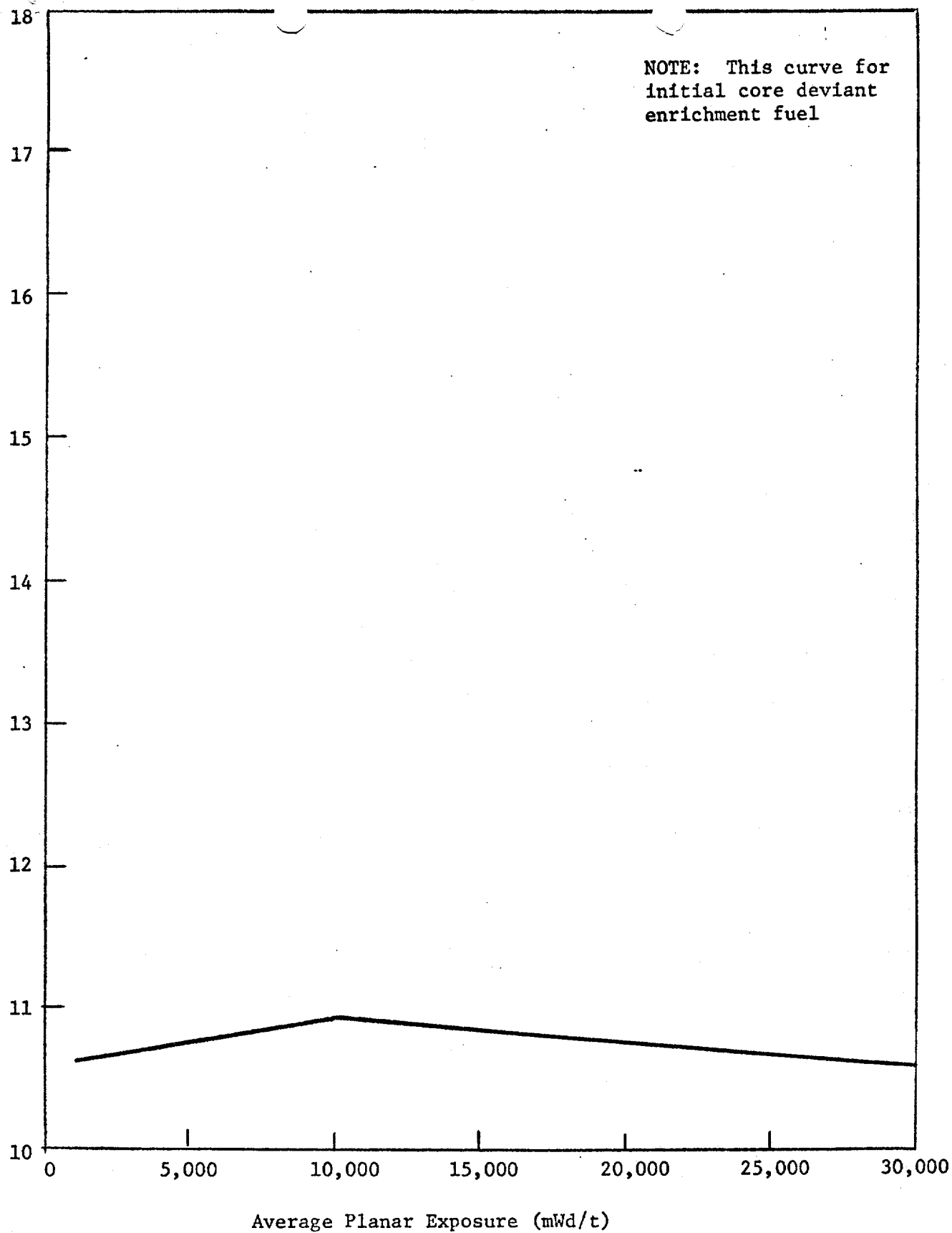
