Ladies and Gentlemen:

In reference (1) Grand Gulf Nuclear Station (GGNS) provided an action plan for the resolution of Generic Letter (GL) 96-06. Subsequent to the original plan, in reference (2) GGNS provided a status, made additional commitments and informed the Commission of the need to defer certain containment penetration resolutions to RFO12. The plan coming out of RFO11 was to have only four penetrations remaining which would require modification in RFO12.

During the course of RFO11, work proceeded as planned and modifications were successfully completed on nine penetrations. The work (installation of a bypass line and adjusting the valve closure torque to a lower value) for the remaining two penetrations (penetrations #87 and #325) could not be successfully performed during RFO11.

Therefore, in addition to completing the four penetrations previously committed to in reference (2), GGNS is committing to satisfactorily resolve penetrations #87 and #325 prior to the end of RFO12. Should you have any questions please contact Lonnie Daughtery at (601) 437-2334.
