ORDER

(Corrections to LBP-01-19)

The Licensing Board revises the slip opinion for LBP-01-19 to incorporate the following corrections:

On page twenty-two, line twenty of the text; page twenty-three, line fourteen of the text; page twenty-six, lines three, eleven, twelve, fourteen, and twenty-two of the text; page twenty-seven, lines three, ten, sixteen, and twenty-four of the text; page twenty-eight, line six of the text; page twenty-nine, line twenty-three of the text; page thirty, lines one and three of the text; page thirty-one, line ten of the text; page thirty-six, line seven of the text, and page fifty-four, lines three and eight of the text, delete the word "the" before the word "Skull".

41. On page thirty-nine, line five of the text, revise the phrase "hazards those declarants prepared, PFS" to read "hazards prepared by those declarants, PFS".
