Dear Sir,

This letter and the associated attachments provides Revisions D, E, F, G, and H to the previously submitted application for amendment to the James A. FitzPatrick Technical Specifications (Reference 1), as supplemented by References 2 and 3, for converting the current Technical Specifications (CTS) to the Improved Technical Specifications (ITS) consistent with the Improved Standard Technical Specifications (NUREG-1433, Revision 1).

Revisions D, E, F, G, and H to the References 1, 2, and 3 submittals include changes consistent with commitments made in References 4, 5, 6, 7, and 8 (except as changed by this letter), License Amendments received since the submittal of Reference 3, certain approved Technical Specification Task Force Travelers, instrumentation Allowable Value changes due to more current setpoint calculations, a few additional new changes, and other typographical and editorial corrections.

Revision D (Attachment 1) includes changes to ITS Chapter 1.0, Chapter 2.0, Section 3.0, Section 3.1, Section 3.2, Section 3.5, Section 3.9, Section 3.10, and Chapter 4.0. Revision E (Attachment 2) includes changes to ITS Section 3.4, Section 3.6, and Section 3.7. Revision F (Attachment 3) includes changes to the Split Report and ITS Section 3.3. Revision G (Attachment 4) includes changes to ITS Section 3.8. Revision H (Attachment 5) includes changes to ITS Chapter 5.0.
