This letter confirms the telephone conversation between Mr. Michael Wallace of your staff and Mr. George MacDonald of this office on May 24, 2001, concerning an Annual Assessment Meeting requested by us which is scheduled for June 27, 2001, at 1:00 p.m. The purpose of the meeting is to discuss the NRC Reactor Oversight Process Annual Assessment of your Shearon Harris Nuclear Power Plant. During the meeting, we recognize that you may have information you want to present to us or any members of the public in attendance. Accordingly, if you so desire, after our presentation you will be afforded an opportunity to respond to any information contained in the Annual Assessment Letter and to discuss any new or existing programs that are designed to maintain or improve your current performance. The location of the meeting will be at the Shearon Harris Administrative Building, Room 228.

Additionally, a separate meeting will be held with state and local government officials at the Shearon Harris Administrative Building, Room 147 shortly after the conclusion of the Annual Assessment Meeting. The purpose of this meeting is to discuss the regulatory role of the NRC, the role of the Shearon Harris resident inspectors, and the avenues that are available to bring concerns to the NRC. Both meetings are open meetings as per "Staff Meetings Open to the Public; Final Policy Statement" (September 20, 2000; 65 FR 56964).

In accordance with 10 CFR 2.790 of the NRC's "Rules of Practice," a copy of this letter will be made available electronically for public inspection in the NRC Public Document Room or from the Publicly Available Records (PARS) component of NRC's document system (ADAMS).
