This letter confirms the telephone conversation between Mr. Harold Chernoff of your staff and Mr. George MacDonald of this office on May 25, 2001, concerning an Annual Assessment Meeting requested by us which is scheduled for July 11, 2001, at 1:30 p.m. The purpose of the meeting is to discuss the NRC Reactor Oversight Process Annual Assessment of your H. B. Robinson Steam Electric Plant Unit 2. During the meeting, we recognize that you may have information you want to present to us or any members of the public in attendance. Accordingly, if you so desire, after our presentation you will be afforded an opportunity to respond to any information contained in the Annual Assessment Letter and to discuss any new or existing programs that are designed to maintain or improve your current performance. The location of the meeting will be at the H. B. Robinson Visitor Center Auditorium.

Additionally, a separate meeting will be held with State and local government officials at the H. B. Robinson Visitor Center Auditorium Conference Room shortly after the conclusion of the Annual Assessment Meeting. The purpose of this meeting is to discuss the regulatory role of the NRC, the role of the H. B. Robinson resident inspectors, and the avenues that are available to bring concerns to the NRC. Both meetings are open meetings as per "Staff Meetings Open to the Public; Final Policy Statement" (September 20, 2000; 65 FR 56964).
