STATE OF UTAH'S REQUEST FOR AN OPPORTUNITY TO BRIEF THE  
LICENSING BOARD'S CERTIFIED QUESTION  
TO THE COMMISSION IN LBP-01-19

On May 31, 2001 the Licensing Board issued Memorandum and Order (Granting in Part and Denying in Part Summary Disposition Motion Regarding Contention Utah K/Confederated Tribes B, Referring Ruling on Aircraft Crash Hazard Regulatory Standard to the Commission), and referred a portion of that decision to the Commission for its consideration. See LBP-01-19. The Licensing Board granted PFS's request to limit its risk standard to 1E-06. Id. at 21. Nevertheless, because of the "significant policy and resource implications" of its risk standard ruling, the Licensing Board certified that portion of its ruling to the Commission. Id.



While the record below contains some information on the risk standard, the State submits that briefs which focus specifically on the appropriate aircraft crash hazard standard will greatly enhance the Commission's review in

this matter.

If the State is permitted to brief the question, the State would not object to the Staff and the Applicant briefing the question at the same time.


