COMPLIANCE NO. 1015 FOR THE NAC-UMS UNIVERSAL STORAGE SYSTEM (AMENDMENT NO. 2 — ADDING

MISCELLANEOUS SPENT FUEL RELATED COMPONENTS TO

THE APPROVED CONTENTS LIST)

I am requesting that the Division of Industrial and Medical Nuclear Safety (IMNS) complete the rulemaking actions necessary to amend Certificate of Compliance (CoC) No. 1015 for the NAC-UMS Universal Storage System. On October 17, 2000, and as supplemented on May 1, 2001, NAC International, Inc. submitted an application and associated Safety Analysis Report (SAR) to amend CoC No. 1015 to add miscellaneous spent fuel related components to the approved contents list for the NAC-UMS storage system and change the required actions in response to a failure of the cask heat removal system. Several other minor administrative changes were also requested. Specific changes would be made to Technical Specifications A1.1, A3.1.6, SR 3.2.1.1, A5.3, A5.4, A5.5, A5.6, B2.13, Table 12B2-6, and Table 12B2-7 to permit the storage of these components and the other requested changes. No changes would be made to the conditions of the Certificate of Compliance.

I have attached for your use draft Federal Register language revising 10 CFR 72.214 and explaining the purpose of the amendment.

We have reviewed the associated SAR in accordance with 10 CFR 72.246 and concluded that issuance of this amendment is warranted. We will provide to IMNS a proposed Amendment No. 2 to CoC No. 1015 and preliminary Safety Evaluation Report by August 17, 2001, for your inclusion in the rulemaking package. I am requesting that this amendment be issued via the direct final rulemaking process in accordance with the generic schedule for CoC rulemakings, previously discussed between our staffs.
