ORDER NO. 2

On June 6, 2001, the parties met as part of their effort to provide the Nuclear Decommissioning Financing Committee (Committee) with stipulations on the issues in this docket. The parties have requested a change in the procedural schedule so they may dedicate more time to stipulations with the goal of providing an agreed-upon position to the Committee on most, and possibly all, issues. The requested revised schedule would be:

Draft Stipulations /or/ prefiled testimony of intervenors and Joint Owners	June 27, 2001	
Prehearing Conference	June 20, 2001	1 PM
Prehearing Conference	June 29, 2001	10 AM
Responsive testimony	July 6, 2001	
Pre-hearing statements	July 6, 2001	

All other dates, including hearing dates, are unchanged, except, as noted below, the Committee may conduct hearings from July 9 – 11, 2001, even if there is a global stipulation of issues.

Further, the parties agreed to the following service requirements:

1. Testimony and supporting exhibits will be served by e-mail no later than noon on the appropriate filing date.
2. Any materials that cannot be transmitted electronically will be delivered to each party no later than the close of business on the appropriate filing date.
3. Service will be made on full parties and limited parties. When possible, limited parties will be served by e-mail.

The Committee accepts the proposed changes and encourages the parties to continue their efforts to stipulate issues in this docket. In addition to the service agreement of the parties, the Committee requests that parties not send e-mails to Committee members, but continue the practice of serving the Committee members by

first class mail. In light of the compressed schedule, particularly with filings on July 6, 2001, parties are directed to mail filings to Committee members for delivery on the filing dates noted above.

Parties are advised that the Committee intends to have a full review of all issues, even those that are addressed by stipulations from the parties. Accordingly, the Committee is prepared to dedicate July 9-11, 2001 to reviewing stipulations, or conducting hearings as needed, in order to be fully advised of the issues before rendering a decision. Parties are advised to plan accordingly.


Based on the foregoing, it is hereby
