<u>ORDER</u>

As directed in the June 19, 2001, telephone conference, the Applicant, Duke Cogema Stone & Webster, shall file a proposed protective order and affidavit of nondisclosure for use in this proceeding to protect the proprietary information in the Applicant's Construction Authorization Request (CAR) from public disclosure. In developing the protective order and affidavit of nondisclosure, the Applicant should keep in mind that the information involved is not safeguards material and that none of the Petitioners are competitors of the Applicant. The proposed order and nondisclosure affidavit should be reasonable and as minimally intrusive as possible upon the Petitioners' ability to speak and write about the license application and underlying issues. With the exception of service upon Petitioner, Environmentalists, Inc., noted below, the Applicant shall file and serve the proposed protective order and affidavit of nondisclosure by electronic mail no later than the 4:30 p.m., Monday, June 25, 2001. To serve Judge Moore, Judge Kelber, and Judge Lam by e-mail transmissions, a participant should (1) send the pleading (which should include the certificate of service) as a file attached to an e-mail message directed to Judge Moore, Judge Kelber, and Judge Kelber, and Judge Lam (Internet IDs: tsm2@nrc.gov;

<u>cnk@nrc.gov; psl@nrc.gov);</u> and (2) send by regular first class mail paper conforming copies that same date addressed, respectively, to Judge Moore, Judge Kelber, and Judge Lam at the Atomic Safety and Licensing Board Panel, U.S. Nuclear Regulatory Commission, Washington, DC 20555. The Applicant shall serve the proposed order and affidavit of nondisclosure on Petitioner Environmentalists, Inc. by overnight mail (e.g., express mail).

Petitioners Foster, Blue Ridge Environmental Defense League, and Georgians Against Nuclear Energy and the NRC Staff shall file with the Licencing Board and serve the other participants their objections to the Applicant's proposed protective order and nondisclosure affidavit by electronic mail no later than 4:30 p.m., Wednesday, June 27, 2001. That same date, these Petitioners and the NRC Staff should send paper conforming copies addressed, respectively, to Judge Moore, Judge Kelber, and Judge Lam by regular mail at the above noted address. These petitioners and the NRC Staff shall serve Petitioner Environmentalists, Inc. by regular first class mail.

Petitioner Environmentalists, Inc. shall file with the Licensing Board any objections to the Applicant's proposed protective order and affidavit of nondisclosure by overnight mail (e.g., express mail). Environmentalists, Inc. shall serve the other participants by regular first class mail.

Once the Licensing Board issues a protective order and approves the affidavit of nondisclosure to be used in this proceeding, those Petitioners wishing to review the proprietary version of the applicant's CAR must properly execute the affidavit of nondisclosure, file it with the Licensing Board, and serve it upon the other participants. The Applicant will have one day to object to any matter involving any Petitioners' affidavit of nondisclosure. Thereafter, the Applicant shall immediately provide each eligible Petitioner with the proprietary version of the CAR.

Finally, as directed by the Commission's referral order, CLI-01-13, 53 NRC ____, ____ (slip op. at 9, June 14, 2001), the Petitioners' contentions shall be filed by July 30, 2001. Therefore, the Petitioners would be well advised to use the publicly available nonproprietary version of the Applicant's CAR in conducting their reviews and preparation of contentions and not await until they have access to the proprietary version of the CAR before beginning such work. Further, in its referral order, the Commission directed that "the presiding officer should not grant requests for extensions of time absent unavoidable and extreme circumstances." <u>Id</u>. at 10.

It is so ORDERED.
