By letter dated February 27, 1998 the Commission issued Amendment Nos. 207 and 188 to Facility Operating License Nos. DPR-70 and DPR-75 for the Salem Nuclear Generating Stations, Unit Nos. 1 and 2. These amendments revised the Technical Specifications (TSs) to adopt Option B, of 10 CFR Part 50, Appendix J, "Primary Reactor Containment Leakage Testing for Water-Cooled Power Reactors," to implement performance-based approach for Type B and C testing. Additionally, the wording in the TSs was modified for the previous adoption of Option B on Type A testing and a section was added on the primary containment leakage rate testing program.
