The licensee presented information related to the design and licensing basis of containment structures which were regarded as degraded but operable since the restart of both units at D. C. Cook. A copy of the handouts used by the licensee is provided in Attachment 2.

The licensee presented background material regarding the status of the containment structures at the time of restart of Unit 2 (June 2000) and Unit 1 (December 2000). The licensee provided the status and the results of the efforts made since the restart of each unit. The licensee indicated that all calculations concerning the containment structures had been completed and the analyses confirmed that all containment structures have an adequate margin and comply with the design basis requirements as stated in the D. C. Cook Updated Final Safety Analysis Report.

The licensee stated in the meeting that the remaining work to be done to close out the subject issue was to complete the necessary documentation to assure that the design basis calculations and all necessary data have been properly processed. In addition, the licensee stated that walkdowns of the Unit 2 containment would be performed during the upcoming refueling outage to obtain as-built measurements of the containment subcompartment area. This information would then be used to confirm that the Unit 2 structural analysis of record remains bounding.
