I am writing to notify you that the U.S. Nuclear Regulatory Commission has initiated the review of the Kerr-McGee Corporation Technical center Decommissioning Plan and request for a license amendment dated April 5, 2001. We will issue a *Federal Register* notice, in accordance with our administrative procedures, stating that we are commencing the review.

We had conducted a completeness review and have determined that the information provided is sufficient to begin the technical review. This completeness review does not reflect the technical adequacy of the information provided. We may periodically request additional information as a result of our technical review.
