ORDER

(Additional Corrections to LBP-01-19)

The Licensing Board revises the slip opinion for LBP-01-19 to incorporate the following additional corrections:

1. On page six, line twenty of the text, change the word “the” to “some”.

3. On page sixteen, line thirteen of the text, insert a comma after the word “occur”.

5. On page seventeen, line three of footnote three; page twenty-six, line nineteen of the text; page thirty-six, line one of the text; page thirty-seven, line nine of the text; page forty-two, line nineteen of the text; page forty-four, line sixteen of the text; and page forty-seven, lines twelve and fourteen of the text, change the word “miles” to “mile”.
6. On page nineteen, line twenty-four of the text, revise the phrase “include a broad” to read “include as broad”.

7. On page twenty-one, line thirteen of the text, insert the word “of” between the words “review” and “any”.

8. On page thirty, line three of the text, revise the phrase “two or four ship” to read “two-or four-ship”.

9. On page thirty-two, lines four and five of the text, change the word “will” to “would”

10. On page thirty-three, line fourteen of the text, delete the word “that” between the words “accidents” and “could”.

11. On page thirty-three, line seventeen of the text, insert the phrase “the occurrence of” before the word “various”.

12. On page thirty-seven, line ten of the text, revise the word “figures” to read “figure”.

13. On page thirty-nine, line nineteen of the text, revise the word “suggests” to read “suggest”.

14. On page forty, line twenty-three of the text, insert the word “the” between the words “with” and “PFS”.

15. On page forty-two, line sixteen of the text, delete the word “the” between the words “by” and “PFS”.

16. On page forty-four, line nineteen of the text, revise the word “takeoff” to read “takeoffs”.

17. On page forty-five, line nine of the text, revise the word “indicates” to read “indicate”.

18. On page fifty, line fifteen of the text, revise the phrase “because it is” to read “because this figure is”.

19. On page fifty-one, line twenty of the text, revise the word “that” to read “those”.

20. On page fifty-two, line nine of the text, revise the word “has” to read “have”.

21. On page fifty-two, line twelve of footnote fourteen, insert the word “be” between the words “will” and “equal”.

26. On page fifty-four, line four of the text, insert the word “attack” between the words “air-to-ground” and “and”.
