The purpose of the meetings was for NEI to present generic activities the industry is undertaking to prepare for licensing of new plants. The generic activities consisted primarily of the creation of four task forces addressing: (1) early site permits; (2) 10 CFR Part 52 licensing processes; (3) financial issues; and (4) creation of a risk-informed, performance-based regulatory framework, which are discussed in greater detail in Enclosures 3 and 4.
