





AFFIDAVIT OF ROBERT G. BYRAM

I, Robert G. Byram, Sr. Vice President and Chief Nuclear Officer of PPL Susquehanna, LLC ("PPL"), do hereby affirm and state:

1. I am an officer of PPL authorized to execute this affidavit on its behalf. I am further authorized to review information submitted to the Nuclear Regulatory Commission and apply for the withholding of information from disclosure.

2. PPL requests that Attachment 1 to PLA-5333 be withheld from public disclosure under the provisions of 10 C.F.R. 2.790(a)(4).

3. The Attachment 1 to PLA-5333 contains confidential commercial information that should be withheld under 10 C.F.R. 2.790(a).


4. This information has been held in confidence by PPL. To the extent that PPL has shared this information with others, it has done so on a confidential basis.

5. There is a rational basis for holding this information in confidence. The Attachment 1 to PLA-5333 contains commercially sensitive information which requires protection in connection with PPL's commercial position in the competitive electric utility industry.


6. This information is customarily held in confidence by PPL in order to protect its competitive position in the marketplace. It is not available from public sources and could not be gathered readily from other publicly available information.
