Subject: Additional Clarification to the Yankee Nuclear Power Station Security  
Plan Relating to Security/Safeguards Measures for Dry Cask Storage

Yankee Atomic Electric Company (YAEC) is preparing to transfer spent fuel from the Yankee Nuclear Power Station (YNPS) Spent Fuel Pool to a dry cask storage facility beginning in the fall of 2001. In support of this activity, YAEC requested Nuclear Regulatory Commission (NRC) review and approval of an amendment to the YNPS Security Plan (References (c) and (d)). In response to our phone discussion on June 27, 2001, YAEC hereby submits this revision to Attachment A of the proposed Security Plan. The section of the Security Plan impacted by this change is marked with a sidebar in the left margin.
