In accordance with the requirements of 10 CFR 50.71, "Maintenance of records, making of reports," paragraph (e), Exelon Generation Company (EGC), LLC, formerly Commonwealth Edison (ComEd) Company, is submitting Revision 4 to the Dresden Nuclear Power Station (DNPS), Units 2 and 3 Updated Final Safety Analysis Report (UFSAR) and Revision 13 to the DNPS Fire Protection Report (FPR). In accordance with 10 CFR 50.71(e)(4), these updates are required to be submitted within 24 months of the previous revisions, which were submitted on June 30, 1999, (i.e., Reference 1) and April 30, 1999, (i.e., Reference 2), respectively. Accordingly, Revision 4 and Revision 13 were due to be submitted by June 30, 2001, and April 30, 2001. respectively. However, due to misunderstanding the response to the Notice of Violation submitted in Reference 3, it was mistakenly considered to be acceptable to submit the next FPR update no later then when the next revision to the UFSAR was due (i.e., June 30, 2001). Therefore, we have placed this self-identified condition into our site corrective action program and will disposition it accordingly. In the future, we plan to continue to submit the periodically required FPR amendment in conjunction with our UFSAR revisions.

As required by 10 CFR 50.71(e)(1), Revision 4 and Revision 13 are submitted on a replacement page basis. Note that the FPR Revision 13 replacement pages are marked as "Amendment 13." In the future, replacement pages will be marked as a revision. The attached instructions provide directions for inserting the revised pages and are accompanied by a list of effective pages for the UFSAR and FPR following page replacement. Changes are indicated by revision bars.

Revisions 4 and 13 include changes made from January 1, 1999, through December 31, 2000. Changes made under the provisions of 10 CFR 50.59, "Changes, tests and experiments," have been previously summarized and provided to the NRC in

References 4 through 11. Accordingly, there are no changes made under the provisions of 10 CFR 50.59 in Revision 4 to the UFSAR or Revision 13 of the FPR that have not been previously submitted to the NRC.

As Director – Licensing, I certify that the information in this submittal accurately presents changes made since the previous submittals necessary to reflect information and analyses submitted to the NRC or prepared pursuant to NRC requirements.

Pursuant to 10 CFR 50.4, "Written communications," paragraph (b)(6), for each document, one signed original and ten copies are being provided to the Document Control Desk, with one copy to NRC Region III and one copy to the DNPS Senior Resident Inspector.
