The debtor is out of business. I recommend that collection activity for this invoice be terminated and the debts be written off. This recommendation is consistent with 10 CFR 15.55(a) which states that collection activity may be terminated when it becomes clear that NRC cannot collect or enforce collection from the debtor having due regard for the judicial remedies available to the NRC, the debtor's future financial prospects, and the exemptions available to the debtor under State and Federal law (e.g., out of business). The amount recommended to be written off is \$6,156.00. We will request a Taxpayer Identification Number and we will issue a 1099C to the IRS with a copy to the debtor.
