Dear Ms. Schossow:

This modification rescinds Modification No. 12 dated August 18, 2000. Pending completion of all required closeout requirements for the subject contract, it is necessary to decrease the task order ceiling and deobligate excess funds remaining under the subject task order. The decrease in ceiling and the deobligation amount do not include that part of the fixed fee not yet paid and still owed to you under the contract terms.

Therefore, the purpose of this modification is to decrease the task order ceiling and deobligate excess funds under the subject task order in the amount of \$9,983.78, hereby decreasing the ceiling and obligated amount from \$524,550 to \$514,566.22. The total reimbursable cost for performance of Task Order No. 2 is \$472,568.22. The fixed fee amount of \$41,998 remains unchanged. Upon contract closeout, the 15% fee withheld (\$6,299.70) will be paid.
