

The purpose of this modification is to exercise option year three. Therefore, Section B.4 Consideration Obligation and Section F.2, Duration of Contract Period are modified accordingly.

1. Section B.4 CONSIDERATION OBLIGATION-DELIVERY ORDERS, paragraphs "a." and "b" are revised to read as follows:

**"B.4. CONSIDERATION OBLIGATION---DELIVERY ORDERS**

- a. The total estimated amount of this contract (ceiling for the products/services ordered, delivered, and accepted under this contract is \$645,549.
- b. The amount obligated by the Government with respect to this delivery order is \$529,977.00. The obligated amount shall, at no time, exceed the ceiling. The Contractor shall notify the Contracting Officer in writing whenever it has reason to believe that the costs it expects to incur under this contract in the next 30 days, when added to all costs previously incurred, will exceed 85 percent of the total amount obligated to the contract by the Government. The notice shall state the estimated amount of additional funds required to continue performance for the period specified in the Schedule. When and if the amount(s) paid and payable to the Contractor hereunder shall equal the obligated amount, the Contractor shall not be obligated to continue performance of the work unless and until the Contracting Officer shall increase the amount obligated with respect to this order. Any work undertaken by the Contractor in excess of the obligated amount specified above is done so at the Contractor's sole risk."

2. Section F.2 DURATION OF CONTRACT PERIOD is revised to read as follows:

**"F.2 DURATION OF CONTRACT PERIOD**

The ordering period for this contract shall commence on July 7, 1997 and will expire on July 6, 2002. Any orders issued during this period shall be completed within the time specified in the order, unless otherwise specified herein. (See 52.216-18, Ordering) "
