

The referenced letters address NRC Generic Letter 95-07 for Callaway Plant. In Reference 6, Ameren UE committed to modifying containment recirculating sump valves EJ-HV-8811A during Refuel 11 and EJ-HV-8811B during Refuel 12. In Reference 7, NRC concluded that, with the commitment to modify these valves, that we have adequately addressed GL 95-07 for Callaway. We were requested to provide a letter stating the actions were completed within 3 months of completing the work..

In Refuel 11, completed May 21, 2001, modifications were made to both of the above listed valves. This completes the long-term actions originally committed to be completed in Refuel 12 (Fall 2002).
