DELETION OF PLANT EMERGENCY PROCEDURE

Gentlemen:

In accordance with 10 CFR 50.54(q) and 10 CFR 50, Appendix E, Section V, Carolina Power & Light (CP&L) Company is notifying the NRC of a change to a plant emergency procedure for the Brunswick Steam Electric Plant (BSEP), Unit Nos. 1 and 2. CP&L has determined that procedure OPEP-Appendix A, "Emergency Response Resources," does not meet the criteria for designation as an Emergency Plan implementing procedure, as described in 10 CFR 50, Appendix E. Therefore, the procedure has been deleted and updates to this procedure will no longer be provided to the NRC. CP&L has evaluated the deletion, in accordance with 10 CFR 50.54(q), and has determined that this change does not decrease the effectiveness of the Radiological Emergency Response Plan; and the Plan, as changed, continues to meet the standards of 10 CFR 50.47(b) and the requirements of 10 CFR 50, Appendix E.
