The purpose of this modification is to: (1) extend the contract term for an additional 12 month period, in accordance with FAR Clause 52.217-8, "OPTION TO EXTEND SERVICES (NOV 1999)" and Subsection I.3, "MUTUAL AGREEMENT TO EXTEND THE TERM OF THE CONTRACT", and (2) change the name of the On-site Manager/Food Service Director. Accordingly, the contract is hereby modified as follows:

1. Under Section F, "DELIVERIES OR PERFORMANCE," Subsection F.3 entitled "DURATION OF CONTRACT PERIOD (MAR 1997, ALTERNATE 2 (MAR 1997)," the paragraph under this subsection is deleted in its entirety and the following sentence is substituted in lieu thereof:

"This contract commenced on June 12, 2000 and will expire on June 11, 2002. The term of this contract may be extended at the option of the Government for three, additional 12-month periods."

An updated SCA Wage Determination has been requested from the U.S. Department of Labor (DOL). When received, if the updated Wage Determination is a newer revision than the one currently in this contract, the Contracting Officer will forward this document to the Contractor for action in accordance with FAR Clause 52.222-43.

All other terms and conditions of this contract remain unchanged.

There is not a summary of obligations from the award date, through the date of this action because this contract is a Profit/Loss, No Cost type contract.
