From June 25 through 28, 2001, Nancy Fragoyannis of the Division of Fuel Cycle Safety and Safeguards led a bilateral physical protection visit to the RA-6 Reactor in San Carlos de Bariloche and the Constituyentes Atomic Center in Buenos Aires, Argentina. Ms. Fragoyannis was accompanied by representatives from the Department of Energy, Defense Threat Reduction Agency, and Sandia National Laboratories. The team was scheduled to visit only the RA-6 Reactor, however during the in-briefing by Argentine staff it was determined that a visit to the Constituyentes Atomic Center (CAC) was necessary. The team reviewed the current physical protection of the reactor and discussed observations and suggestions with the Argentine staff. Observations and recommendations on the CAC were forwarded to the U.S. Embassy by classified cable following the visit due to time constraints. An Embassy representative will forward the team's observations to the Argentine staff. Classified detailed information concerning this subject is available for review. A classified interagency report will be available for review in approximately 30 days.
