Gentlemen:

This letter provides information in accordance with 10 CFR 50.54(p)(2) concerning changes at Wolf Creek Generating Station (WCGS) affecting the WCGS Physical Security Plan, the Safeguards Contingency Plan, and the Security Training and Qualification Plan. Attachment I provides a description of these changes and a justification for the changes. Attachment II identifies the commitments as a result of this correspondence.

Changes identified in Attachment I will be incorporated into the WCGS Physical Security Plan, the Safeguards Contingency Plan, and the Security Training and Qualification Plan by January 31, 2002. These changes include Wolf Creek Nuclear Operating Corporation organization changes and installation of a new radio system. These changes do not reduce the effectiveness of the WCGS Physical Security Plan, the Safeguards Contingency Plan, or the Security Training and Qualification Plan.

Reasons and Justifications

Change 1

Pages Affected:

Physical Security Plan - iii, xx, 1-1, 1-2, 1-3, 1-4, 1-6, 1-7, 1-17, 3-42, 5-7, 9-4, 13-2,

Security Training and Qualification Plan - vi. A-6, A-46, A-55.

Change:

This change replaces the title of Vice President Operations Support with the title of

Vice President Operations.

Reason for Change:

The position of Vice President Operations Support has been eliminated. Therefore, changes were made to the WCNOC organizational structure. The Vice President Operations has been assigned responsibility for Wolf Creek Generation Station

Security.

Justification:

All responsibilities are being maintained. The Vice President Operations will be responsible for all Security activities that were previously the responsibility of the Vice President Operations Support. No responsibilities are being reduced. This organization change has no effect on the implementation of the Physical Security Plan, the Safeguards Contingency Plan, or the Security Training and Qualification Plan. Therefore, this change does not reduce the effectiveness of the Physical Security Plan, the Safeguards Contingency Plan, or the Security Training and

Qualification Plan.

Pages Affected:

Physical Security Plan - xix, 6-3, 6-5, 7-1,

Safeguards Contingency Plan - 3-6

Change:

This change removes the term FM and VHF from the Physical Security Plan and

the Safeguards Contingency Plan.

Reason for Change:

Wolf Creek Generating Station is installing a new radio system. With the

installation of this new radio system, the terms FM and VHF are no longer accurate.

Justification:

This change will correct the inaccuracy described above. The new term 900MHz will not be added in the plan description. Rather, the plans will state "Radio," or "Radio system." This change does not reduce the capability of continuous communications capability of the Security Force and has no effect on the implementation of the Physical Security Plan, the Safeguards Contingency Plan, or the Training and Qualification Plan. Therefore this change does not reduce the effectiveness of the Physical Security Plan, the Safeguards Contingency Plan, or the Security Training and Qualification Plan.
