NOTICE OF PROPOSED ISSUANCE OF AMENDMENTS TO PACILITY OPERATING LICENSES

The Buclear Regulatory Commission (the Commission) is considering the issuance of amendments to Facility Operating Licenses No. DPR-38, DPR-47, and DPR-55 issued to Duke Power Company (the licensee) for operation of the Oconee Nuclear Station, Units 1, 2, and 3 (the facility), pressurized-water reactors iscated in Oconee County, South Carolina, and each currently authorized for operation at power levels up to 2568 MWt.

In accordance with the licensee's application for license amendments dated July 9, 1975, the smendments would modify operating limits in the Technical Specifications based upon an evaluation of ECCS performance calculated in accordance with an acceptable evaluation model that conforms to the requirements of the Commission's regulations in 10 CFR Section 50.46. The amendments would modify various limits established in accordance with the Commission's Interim Acceptance Criteria, and would, with respect to the Oconee Buclear Station, Units 1, 2, and 3, terminate the further restrictions imposed by the Commission's December 27, 1974 Order for Modification of License, and would impose

A petition for leave to intervene must be accompanied by a supporting affidavit which identifies the specific aspect or aspects of the proceeding as to which intervention is desired and specifies with particularity the facts on which the petitioner relies as to both his interest and his contentions with regard to each aspect on which intervention is requested. Petitions stating contentions relating only to matters outside the Commission's jurisdictions will be desied.

All petitions will be acted upon by the Commission or licensing board designated by the Commission or by the Chairman of the Atomic Safety and Licensing Board Panel. Timely petitions will be considered to determine whether a hearing should be noticed or another appropriate order issued regarding the disposition of the petitions.
