NOTICE OF MOTION AND MOTION

PLEASE TAKE NOTICE that, pursuant to an (oral) order shortening time, issued by the Court on July 27, 2001, on August 3, 2001, at 1:30 p.m., or as soon thereafter as the matter may be heard, in the Courtroom of the Honorable Dennis Montali, located at 235 Pine Street, 22nd Floor, San Francisco, California, Pacific Gas and Electric Company, the debtor and debtor-in-possession in the above-captioned Chapter 11 case ("PG&E" or the "Debtor"), will and hereby does move (the "Motion") the Court for entry of an order granting PG&E authority, without need for further hearing or additional notice to creditors or parties in interest (except the Official Committee of Unsecured Creditors), to (a) enter into amendments of power purchase agreements ("PPAs") between PG&E and certain "Oualifying Facilities" ("OFs"), and (b) assume such amended PPAs pursuant to sections 365(b)(1) and (d)(2) of the United States Bankruptcy Code, each on terms set forth in the proposed form of "Amendment to Power Purchase Agreement" and "Agreement," true and correct copies of which are attached as Exhibits "A" and "B" to the Declaration of Janos Laszlo, which has been filed concurrently herewith. Please take further notice that while the form of Agreement generally provides that the "cure" of any pre-petition claim under a PPA will not commence until the earlier of (i) the occurrence of the "Effective Date" of a plan of reorganization confirmed in this Chapter 11 case, or (ii) July 15, 2003, the form of Agreement also includes a provision which would permit PG&E to pay immediately the amount necessary to cure pre-petition defaults for any QF to which the pre-petition default is equal or less than \$10,000.
