Dear Mr. Beasley:

This refers to two meetings conducted at our request at the Vogtle Electric Generating Plant Administrative Building Auditorium on July 17, 2001. The first meeting was the Annual Assessment meeting. The purpose of this meeting was to discuss the NRC's Reactor Oversight Process (ROP) annual assessment of safety performance for Vogtle Electric Generating Plant for the period of April 2, 2000 - March 31, 2001.

The major topics addressed were: the NRC's assessment program, the results of the Vogtle Electric Generating Plant assessment, and the NRC's Agency Action Matrix. Attendees included Southern Nuclear Operating Company (SNC) site and corporate management, SNC staff, NRC staff, and 4 local officials.

Following the annual assessment meeting, a separate meeting was held with local officials to discuss the ROP and NRC activities involving Vogtle Electric Generating Plant. Attendees included NRC staff and 3 local officials.

Both of the meetings were open to the public. Information used for the discussions of the ROP is available from the NRC's document system (ADAMS) as accession number ML 011980088 which can be accessed from the electronic address provided below.
