I am writing to ask for an extension of the comment period time because I was not aware of the Federal Register until today and I have questions which I would like the NRC to address.

I feel the community's right to know and subsequently comment on this issue should be a higher priority than an arbitrary time line.

Please consider that a problem with the canister can result in a major catastrophe in which the community will suffer the most damage.

My main concerns and questions about the canister are:

1. There will be less shielding and protection to keep the weight down for transportation.
2. How long is the helium guaranteed to safely protect the canister without being re-pressurized?
3. If the canisters have to be opened what is the method for resealing the canister?
4. Have the canisters ever been opened anywhere in the country?
5. Have the canisters been field-tested?
6. Can you explain how the reverse of the law of thermal dynamics can be applied to unload the cask?

I hope you will appreciate the importance of these questions as they pertain to this issue. I thank you for your time and consideration on this important matter.
