

AMENDMENT TO CONSTRUCTION PERMIT

Amendment No. 2
Construction Permit No. CPPR-94

1. The Atomic Energy Commission (the Commission) having found that:
 - A. The application for amendment filed as Amendment No. 21 to the Application for License, dated May 17, 1974, complies with the standards and requirements of the Atomic Energy Act of 1954, as amended, and the Commission's rules and regulations set forth in 10 CFR Chapter I;
 - B. The South Carolina Electric and Gas Company and the South Carolina Public Service Authority are financially qualified to design and construct the proposed facility;
 - C. The issuance of this amendment will not be inimical to the common defense and security or to the health and safety of the public; and
 - D. No request for a hearing or petition for leave to intervene was filed following notice of the proposed action.
2. Accordingly, Construction Permit No. CPPR-94 is amended to reflect a change in the ownership of the facility as follows:
 - A. Paragraph 1. is deleted and the following is substituted:
 - "1. Pursuant to Section 103 of the Atomic Energy Act of 1954, as amended (the Act), and Title 10, Chapter 1, Code of Federal Regulations, Part 50, "Licensing of Production and Utilization Facilities," and pursuant to the Initial Decision of the Atomic Safety and Licensing Board, the Atomic Energy Commission (the Commission) hereby issues a construction permit to the

South Carolina Electric and Gas Company and South Carolina Public Service Authority (the applicants), as their interests appear in the application, as amended, for a utilization facility (the facility), designed to operate at 2775 megawatts thermal with a net electrical output of approximately 900 megawatts as described in the application and amendments thereto, (the application), filed in this matter by the applicants and as more fully described in the evidence received at the public hearing upon the application. The facility, known as the Virgil C. Summer Nuclear Station, Unit 1, will be located at the site in Fairfield County, South Carolina. The site is located immediately north of Parr, South Carolina, and is adjacent to the Monticello Reservoir created by placing a series of dams across Frees Creek, a tributary of the Broad River. The Reservoir is located east of the Broad River and west of South Carolina State Highway 215, about 26 miles north of Columbia, in western Fairfield County, South Carolina."

B. In accordance with paragraph a.1, all further references in Construction Permit No. CPPR-94 to "applicant" are deleted and "applicants" is substituted.

3. This amendment is effective as of the date of its issuance.

NOTICE OF ISSUANCE OF AMENDMENT TO

CONSTRUCTION PERMIT

Notice is hereby given that the U. S. Atomic Energy Commission (the Commission) has issued Amendment No. 2 to Construction Permit No. CPPR-94 issued to South Carolina Electric and Gas Company. Notice of the proposed action was published in the Federal Register on October 17, 1974 (39 F. R. 37088). No request for hearing or request for petition to intervene was filed. The amendment reflects a change in ownership of Virgil C. Summer Nuclear Station, Unit No. 1 (the facility), located in Fairfield County, South Carolina. The amendment is effective as of its date of issuance.

The amendment permits South Carolina Public Service Authority to receive a one-third ownership in the facility. South Carolina Electric and Gas Company retains sole responsibility for the overall technical direction in the licensing, design, construction, operation, management, maintenance and decommissioning of the facility.

The application for the amendment complies with the standards and requirements of the Atomic Energy Act of 1954, as amended (the Act), and the Commission's rules and regulations. The Commission has made appropriate findings as required by the Act and the Commission's rules and regulations in 10 CFR Chapter I, which are set forth in the amendment.

For further details with respect to this action, see (1) the application for amendment dated May 17, 1974, (2) Amendment No. 2 to Construction Permit No. CPPR-94, and (3) the Commission's related Safety Evaluation. All of these items are available for public inspection at the Commission's Public Document Room, 1717 H Street, N. W., Washington, D. C. and at the Fairfield County Library, Vanderhorst Street, Winnsboro, South Carolina.
