SUBJECT: NAVY TERMINATED SITES

Dear CAPT Higgins:

In accordance with our recent discussions, we request that the Navy review for closure, the enclosed list of formerly terminated licensed sites. We appreciate your past efforts in this area, and we believe that these are the last of the terminated sites remaining open. Please provide any information that can be used to support closure of the file, such as close out surveys or final disposition of licensed material. When resolved, or when all reasonable efforts to resolve are exhausted, please provide NRC Region II a brief summary of the findings for each file.

We have sent the original subject files directly to Mr. William Morris. We would appreciate these files being returned when you are done with them so that we may archive them in our central files.

In addition, there is licensed material used under NRC License No. 52-13137-01, which was issued to the Department of Health, Education, and Welfare in 1969 and terminated in 1970, that may be buried on or near the US Naval Radio Station in Sabana Seca, Puerto Rico. We would appreciate it if you could provide any information you may have concerning this burial area. We are attaching pertinent information and a map to this letter.
