SUBJECT: MEETING SUMMARY - CATAWBA NUCLEAR STATION

Dear Mr. Peterson:

This meeting summary documents two meetings conducted at the Catawba Nuclear Station Administration Building on July 11, 2001. Both meetings were open to the public.

The first meeting was the Annual Assessment meeting. The purpose of this meeting was to discuss the NRC's Reactor Oversight Process (ROP) annual assessment of safety performance for Catawba Nuclear Station for the period of April 2, 2000 - March 31, 2001. The major topics addressed were: the NRC's ROP assessment program, the results of the Catawba Nuclear Station assessment, and the NRC's Agency Action Matrix. Attendees included members of Duke Energy Corporation site management and staff, local news media, members of the public and members of the NRC staff. The second meeting was held with state and local officials, and members of the public to discuss the ROP and NRC activities involving Catawba Nuclear Station.
