Dear Ms. Plettinger:

On January 24, 2001, Entergy Operations, Inc. (EOI) requested that the River Bend Station Technical Specification provisions related to reactor coolant system pressure and temperature limits be amended. In support of the application, EOI provided General Electric (GE) topical report GE-NE-B13-02094-00-01, "Pressure Temperature Curves for Entergy Operations, Inc. (EOI) Using the K_{ic} Methodology," in both proprietary and non-proprietary versions. The staff reviewed the content of the proprietary topical report and, by letter dated March 23, 2001, found that the information should be withheld from public disclosure. On May 3, 2001, the staff generated a Request for Additional Information (RAI) pertaining to the GE topical report, a copy of which was sent to you as well as other members of the public on the courtesy copy list. On June 26, 2001, the staff was verbally informed by EOI that GE had identified that two of the RAI questions contained proprietary information.

Once the staff became aware that proprietary information had been inadvertently released to the public, a number of steps were taken to rectify the situation, including removing the RAI from public availability in the Nuclear Regulatory Commission (NRC) Agencywide Documents Access and Management System (ADAMS) and preparing a non-proprietary version of the RAI for placement in ADAMS.

In an effort to retrieve the copies of the RAI that were sent to those on the courtesy copy list, we request that you return to the NRC your copy of the RAI, along with any additional copies that were made of it, using the enclosed self-addressed, postage-paid envelope. A copy of the non-proprietary version of the RAI will be sent to you as soon as it is entered into ADAMS.
